2008 Farmers' Market Rules & Regulations

- Applicants shall only display or advertise items that have been approved for sale. Approved for sale means that the Hollister Downtown Association Certified Farmers Market (HDACFM) Committee has approved your product(s) listed on the reverse side of this application.
- All required permits and licenses must be available during selling hours. This includes, but is not limited to, the Certified Producers Certificate, Organic Registration, and if giving out samples and/or selling prepared food, a San Benito County Health Permit.
- All Applicants are responsible for paying his or her stall fee to the Market Manager during market hours.
- Applicants must accept the space given to them by the Market Manager.
- **All Applicants must be set up in their assigned stall by 2:30 pm.** Applicants may begin selling at any time, but no earlier than 2:00 pm.
- Applicants must call the Market office if they will be late on a given day. Excessive tardiness will result in loss of booth space.
- Applicants must call the Market office if they are not coming to the Market. If an Applicant fails to notify the Market Manager of his/her intention not to sell at the Market on a specific day, the Applicant will be required to pay a fine of \$25 (that must be paid prior to selling again at the market).
- Applicants must maintain and leave their stall space(s) in a safe, clean, and sanitary condition. **Applicants are not permitted to use the market trashcans.** Applicants are responsible for bringing their own receptacles for their own waste. Sprinklers on the lawn will be clearly marked; you are responsible for repairs if caused by your property (i.e. tents, vehicles etc.) When using tents they **MUST** be secure and are your own responsibility.
- No leaving early, even if sold out.
- Applicants may not leave due to rain unless directed to do so by the Market Manager.
- Smoking or drinking of alcoholic beverages is not permitted in any of the stall spaces.
- Applicants are responsible for the actions of their employees, representatives, or agents.
- All Applicants must comply with all applicable Federal, State, County and local laws, ordinances and regulations.

By being accepted for membership and selling at the Hollister Downtown Association Certified Farmers' Market (HDACFM), the applicant agrees to abide by all State, Local, and HDACFM rules and regulations, and all decisions made by the Market Manager and the HDACFM Committee. The applicant agrees to indemnify and save harmless the Hollister Downtown Association, its Board of Directors, agents, servants, and employees from any damage, injury, or loss to any persons, including, but not limited to persons who the applicant may be liable under any Workman's Compensation Law and the seller him/herself, and from any loss damages, caused of action claims or suits for damages or in any other liabilities whatsoever, for the failure to operate a Market due to holidays, destruction by fire, other calamity, or by an act of God, strikes, statues, ordinances, or any legal authority or any other cause beyond the HDACFM's control.
