1. Gingerbread Houses **MUST BE EDIBLE**. Graham crackers, cookies, or other pre-made foods may be used for the buildings instead of traditional gingerbread, but please, no cardboard or plastic. Non-edible decorations may be used around the Gingerbread House as part of the landscape.
2. Size limitations require houses and landscapes to fit on a 24 inch by 24 inch display board (576 square inches maximum).
